1. ACCEPTANCE OF TERMS

Welcome to VanHelsingCurse.com!. We provide our service to you, subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. You can review the most current version of the TOS at any time by clicking on TOS at the bottom of any page. In addition, when using particular VanHelsingCurse.com owned or operated services, you and VanHelsingCurse.com shall be subject to any posted guidelines or rules applicable to such services which may be posted from time to time. All such guidelines or rules (including but not limited to our Spam Policy) are hereby incorporated by reference into the TOS. VanHelsingCurse.com may also offer other services that are governed by different Terms of Service.

2. DESCRIPTION OF SERVICE

VanHelsingCurse.com currently provides users with access to a rich collection of resources, including, chat, forums, and branded programming through its network of properties (the "Service").
